Improvements to be made in 2017 when Minnesota Student Survey Data is analyzed. (ii) Developed information sheets detailing changes in funding to afterschool in Minnesota. (iii) provided technical assistance, STEM activity, and coordinated statewide communication efforts that supported over 115 Lights on Afterschool awareness events across the state.
